#### <u>COMMUNITY DEVELOPMENT – Trustee Thon/Trustee Baumer</u>

#### A-23-044 Ordinance – Special Use for Video Gaming/Liquor – 533 S. Bartlett Road

Request the Board approve an Ordinance entitled "AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO ALLOW FOR THE OPERATION OF A RESTAURANT WITH THE SERVICE OF ALCOHOLIC BEVERAGES AND A SPECIAL USE PERMIT TO ALLOW FOR THE OPERATION OF A VIDEO GAMING ESTABLISHMENT IN A C-2 COMMERCIAL DISTRICT LOCATED AT 533 S. BARTLETT ROAD." This Ordinance approves two special use permits to allow the sale and service of alcoholic beverages within a restaurant and to allow an establishment utilizing video gaming to be known as Wings & Chaching at 533 S. Bartlett Road.

Trustee Schmidt seconded the motion. Community Development Director Jeff Harris noted testimony provided at the April 6<sup>th</sup> meeting from members of the Islamic Mosque and Unity Academy located north of this shopping center. After re-evaluating the information, and obtaining more detailed information from the police department, it is noted that the Planning and Zoning Board discussed the proximity of the Mosque and school but no one was present at that meeting. State law regulates the distance for alcohol sales in proximity to schools and houses of worship which is 100 feet. The location of this business, while 20 feet closer than the recommended 500 foot separation between gaming uses, is fully shielded from view from the church or school. The main use is as a restaurant with ancillary uses for alcohol and gaming. Staff is concurring with the favorably recommendation from the Planning and Zoning Board.

Dr. Faezi of IMAMI expressed concerns for past vandalism and the lack of follow-up by anyone from the Police Department. Police Chief Taylor stated there should be follow up depending on the assignment of the report and will check into the past incidents. Mr. Abbas and several parents again stated their concerns about this business and its proximity to the church and school. Trustee Harper asked if the church and school have security cameras. Mr. Abbas stated the interior cameras are working but the exterior are not. Mr. Chris DiFranco, owner of the shopping center and proposed restaurant, stated they have been in the business for many years, have gaming at their current location, and have not had any criminal activity. Request the Board approve a Resolution entitled "A RESOLUTION AUTHORIZING THE EXECUTION OF A DEVELOPMENT ASSISTANCE PROGRAM AGREEMENT WITH INFINITY BEAUTY SALON IN THE VILLAGE OF STREAMWOOD." This Resolution approves a Development Assistance Program grant request from Infinity Beauty Salon located at 305 S. Bartlett Road, Unit E, for \$3,629.32.

Trustee Thon presented the Resolution and moved for approval. Trustee Baumer seconded the motion. Community Development Director Jeff Harris stated this salon is the end unit in a five-unit commercial condo building. It has operated as a salon for the last 17 years with various operators; the owner has been operating the business for the past 5 years. She is requesting grant funds to install a new channel letter sign on the exterior and new vinyl signage on the windows. This will also bring the exterior sign into current Code compliance. The total cost (lowest of three estimates) is \$7,258.65 and the grant reimbursement will be 50% of the cost. Owner Margaret Kulesza was present for questions. ROLL CALL:

#### A-23-050 Ordinance – Amending BOFPC Rules and Regulations

Request the Board approve an Ordinance entitled "AN ORDINANCE APPROVING THE REVISED AND AMENDED RULES AND REGULATIONS OF THE VILLAGE OF STREAMWOOD BOARD OF FIRE AND POLICE COMMISSIONERS STREAMWOOD, COOK COUNTY, ILLINOIS." This Ordinance revises and amends the Rules and Regulations of the Village of Streamwood Board of Fire and Police Commissioners (BOFPC) to revise requirements candidate testing.

Trustee Schmidt presented the Ordinance for first reading. Fire Chief Mike Meyer stated the changes include no longer requiring a minimum of 60 semester hours of college credit; a high school diploma or GED is required. Additional preference points will be given for college credit. Also the physical testing, CPAT or POWER, need not be submitted at time of application; it will be required at time of final eligibility list creation. Other amendments are proposed to maintain compliance with state law, current terminology and memorializing existing practices. The BOFPC met on April 6, 2023 and voted

unanimously in favor of the proposed amendments. Police Chief Shawn Taylor concurred with Chief Meyer's summary. Trustee Harper asked the minimum age for applicants. Chief Meyer stated for fire it is 18 years; police is 21 years.

Trustee Schmidt moved to waive the first reading for the Ordinance. Trustee Haque seconded the motion. A voice vote approved waiving the first reading. Trustee Schmidt moved to approve the Ordinance as presented. Trustee Baumer seconded the motion. ROLL CALL:

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AMENDMENTS TO THE REMINGTON RIDGE (SUTTON RIDGE) TOWNHOME ASSOCIATION DECLARATION OF COVENANTS, CONDITIONS, EASEMENTS AND RESTRICTIONS." This Resolution approves amendments to the Remington Ridge Townhome Association Declaration of Covenants, Conditions, Easements and Restrictions giving homeowners responsibility for exterior deck maintenance.

The amendment still requires all decks and stairs be maintained in good condition and also needs HOA approval for any/all work being done on decks and/or stairs, with village-issued permits if needed.
