Commission Resignation and Reappointment

President Billie Roth requested concurrence with the resignation of Anissa Upshaw from the Community Relations Commission. Trustee Harper moved for approval. Trustee Baumer seconded the motion. A voice vote approved the appointment.

President Billie Roth requested concurrence with the reappointment of Sandy Stewart as a member of the Planning and Zoning Board for a 4-year term expiring May 2027, Ronald Franczak as member of the Police Pension Board and Steve Wilson as a member of the Veterans Memorial Commission each with 2-year terms expiring May 2025. A-23-061 Resolution – Agreement with U-46 – School Resource Officer

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE PRESIDENT TO EXECUTE ON BEHALF OF THE VILLAGE OF STREAMWOOD AND AUTHORIZING THE VILLAGE CLERK TO ATTEST TO A CERTAIN AGREEMENT WITH SCHOOL DISTRICT U-46 FOR THE PROVISION OF A SCHOOL RESOURCE OFFICER." This Resolution authorizes an agreement with School District U-46 for the provision of three (3) school resource officers for the 2023-2024 school year.

Police Chief Shawn Taylor noted the Streamwood Police Department has provided school liaison officers at Streamwood High School, Tefft Middle School, and Canton Middle School for several years now, with the Village and School District U-46 sharing the officer salary and benefits costs. A-23-062 Resolution – Waive Competitive Bid – Vehicle Purchase – Police Department

Request the Board approve a Resolution entitled "A RESOLUTION WAIVING COMPETITIVE BIDDING, AND APPROVING AND AUTHORIZING THE VILLAGE TO PURCHASE THREE VEHICLES FOR THE POLICE DEPARTMENT." This Resolution waives competitive bidding and accepts a proposal from Currie Motors for the purchase of three vehicles for the Police Department in the amount of \$171,197. Funds for the vehicles are included in the 2023 Equipment Replacement Fund.

Trustee Cecille presented the Resolution and moved for approval. Trustee Haque seconded the motion. Police Chief Taylor said he's seeking approval to purchase two 2023 Chevrolet Silverado pick-up trucks and one 2023 Ford Interceptor SUV. These vehicles will replace vehicles that are scheduled to be replaced. He noted contracts for police squads have been delayed due to supply chain shortages, so they are seeking to waive bidding since no state or local bids are available. Trustee Harper commented that our fleet is Ford based and asked whether Public Works would now need to stock Chevrolet parts due to this purchase. Public Works Director Matt Mann said he didn't foresee any problems with obtaining Chevrolet parts when needed.

Trustee Harper asked if the pick-up trucks are 4-wheel drive and expressed concern about traction in the winter. Chief Taylor said he was unsure about the 4-wheel drive and would get back to the Board with that information. ROLL CALL:

A-23-064 Ordinance – Liquor License Classifications – Class F and V
