VILLAGE MANAGER'S REPORT:

Village Manager Sharon Caddigan stated Streamwood Summer Celebration was a great success, even with needing to close early on Friday evening due to storms.

An EF-0 tornado made a brief touchdown in Streamwood on July 12 around 6:40 p.m. along Ramblewood Drive. There was some building and sign damage (Portillo's, Aldi's (under construction)) and a couple of vehicles damaged by debris. No injuries were reported.

Cook County has started the Schaumburg Road construction (from East Ave west to Route 59). Anticipate delays along this route.

A-23-078 Ordinance – Special Use Permit – 7-Eleven – 2 E. Irving Park Road

Request the Board approve an Ordinance entitled "AN ORDINANCE GRANTING A SPECIAL USE PERMIT TO ALLOW FOR THE SALE OF PACKAGED ALCOHOLIC BEVERAGES FOR OFF-PREMISES CONSUMPTION IN A C-2 NEIGHBORHOOD COMMERCIAL DISTRICT LOCATED AT 2 E. IRVING PARK ROAD." This Ordinance approves a special use permit to allow for the sale and service of alcoholic beverages within an existing gas station convenience store in a C-2 District for 7-Eleven at 2 E. Irving Park Road.

Trustee Baumer presented the Ordinance for first reading. Community Development Director Jeff Harris stated this store is transferring from corporate operation to a new franchisee and they wish to keep the current alcohol sales. It is a 3,000 square foot store; Village guidelines would allow up to 300 square feet for alcohol sales/display. They are requesting to keep the existing 10 square feet which includes one 8 square foot cooler, and 2 feet of floor space. The Planning and Zoning Board heard this petition and recommended in favor; staff concurs. Dave Zamora, representing 7-11 corporate, and Rinki Shah, the new franchisee were present for questions. Trustee Cecille asked if any interior remodeling is planned; Mr. Zamora stated it is on the schedule in the future. Ms. Shah asked the Board to consider waiving the first reading.

A-23-079 Ordinance – Special Use Amendment – Burger King – 111 E. Irving Park Road

Request the Board approve an Ordinance entitled "AN ORDINANCE GRANTING A SPECIAL USE AMENDMENT TO MODIFY EXISTING DRIVE-THROUGH FACILITIES, AUTHORIZING AN ELECTRONIC MESSAGE CENTER SIGN, AND AUTHORIZING VARIANCES FOR A RESTAURANT AT 111 EAST IRVING PARK ROAD." This Ordinance approves a special use amendment to modify the existing drive through facilities, to allow for an electronic message center sign, and authorizes sign variances at the Burger King located at 111 E. Irving Park Road.

Trustee Baumer presented the Ordinance for first reading. Community Development Director Jeff Harris stated this location was built and opened in 2001. The restaurant is approximately 3,800 square feet; 1,300 square feet is kitchen area, 1,700 square feet is dining room and 800 square feet is indoor playground. Currently there is a single lane drive through that starts on the north side and wraps to the west side. There are 19 parking spaces on site and a shared parking agreement with Woodland Heights Shopping Center for an additional 40 spaces. The Planning and Zoning Board heard the petition proposing removal of the playland area and installation of a second drive through ordering lane. The façade will also be updated and signage on site will be updated. All requested plans have been submitted. John Kayser, Cave Enterprises, franchisee and Thomas from MRV Architects were present for questions. Mr. Kayser noted the building will get a total refresh to bring it to current BK logo standards and design. They provided a review of the overall plans for the site, signage building design. Mr. Kayser asked the Board to consider waiving the first reading.

A-23-080 Resolution – Vehicles Purchase – Police Department

This Resolution waives competitive bidding and accepts the proposal from Bob Ridings Ford, Inc., for the purchase of two 2023 Ford Police Interceptor 4-door utility vehicles for a total cost of approximately \$92,766 for use in the Police Department.
