### A-23-085 Motion – Purchase of Public Works Vehicle

Request the Board approve a Motion to purchase a Ford F-250 truck from Sutton Ford for the Public Works Department at a total cost of \$47,302.

This motion permits the purchase of one vehicle for use in the Public Works Department. Funds for this purchase are included in the 2023 Equipment Replacement Fund.

Trustee Haque presented the Motion and moved for approval. Trustee Baumer seconded the motion. Public Works Director Matt Mann stated this is a planned replacement for a 2008 F250 truck in the Forestry Department. The Suburban Purchasing Cooperative is the low bid for this vehicle and it comes with a standard 3-year, 36,000 mile warranty, and a

5-year, 60,000 mile power train warranty. Trustee Cecille confirmed that the plow equipment will be installed after the vehicle is received. ROLL CALL:

#### A-23-086 Resolution – Approval of Labor Agreement / Metropolitan Alliance of Police Chapter #216

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF A LABOR AGREEMENT WITH THE METROPOLITAN ALLIANCE OF POLICE, STREAMWOOD POLICE CHAPTER #216 (POLICE DEPARTMENT SWORN)." This Resolution approves a three-year collective bargaining agreement with the Metropolitan Alliance of Police (MAP), Local 216 which will be effective January 1, 2022 through December 31, 2024.

Trustee Cecille presented the Resolution and moved for approval. Trustee Haque seconded the motion. Police Chief Shawn Taylor reviewed the three-year agreement noting a \$2,000 across-the-board equity adjustment and wage increases of 4%-3.5%-3% through 12/31/2024. The agreement also has new sections regarding body-worn camera and wellness efforts in compliance with recent legislation, parity on holiday pay for all unit members and language for the comfort dog into definitions and duties. The agreement was ratified by the membership on August 9. Village Manager Caddigan noted the changes in state law added to the delays in negotiations for this agreement. ROLL CALL:
