A-22-002 Ordinance – Special Use and Planned Development - Car Wash – 14 E. Irving Park Road

Request the Board approve an Ordinance entitled "AN ORDINANCE APPROVING A PLANNED DEVELOPMENT AGREEMENT, REZONING AND SPECIAL USE WITH VARIATIONS FOR THE PROPERTY LOCATED AT 14 E. IRVING PARK ROAD, STREAMWOOD, ILLINOIS." This Ordinance approves a Special Use for a Planned Unit Development to redevelop the former Mason's Car Wash at 14 E. Irving Park Road into a new car wash facility to be known as Extreme Clean Car Wash.

Trustee Thon presented the Ordinance for second reading and moved for approval. Trustee Haque seconded the motion. Community Development Director Jeff Harris noted the first reading for this Ordinance was in January 2022, and the owner/developer has been working with IDOT regarding the access. This was further delayed during the construction by IDOT and Cook County at this intersection. The agreed upon access will allow right in/right out and eastbound left in; there will be no permitted left out (heading east) onto Irving Park Road. There is a cross access agreement with the adjacent 7-Eleven/Mobil to the west to facilitate additional access. A-23-087 Ordinance – First Amendment to PUD Agreement – Electronic Message Center Sign – Poplar Creek Library

Request the Board approve an Ordinance entitled "AN ORDINANCE APPROVING A FIRST AMENDMENT TO A PLANNED UNIT DEVELOPMENT AGREEMENT AND AUTHORIZING THE EXECUTION OF A FIRST AMENDMENT TO A PLANNED UNIT DEVELOPMENT AGREEMENT WITH POPLAR CREEK LIBRARY DISTRICT." This Ordinance approves the requested Planned Unit Development (PUD) agreement amendment to allow for an electronic message center sign for Poplar Creek Public Library.

Trustee Thon presented the Ordinance for first reading. Community Development Director Jeff Harris stated the library property is governed by a PUD agreement from 2007 which includes the existing monument sign on the west side of Park Ave. They are seeking an amendment allowing the removal of the concrete monument sign to replace it with an electronic message center (EMC) sign. It will be a 20 square foot (2.5'x8') EMC on top of

a like-sized base, and will be set back 5 feet from the west property line. Landscaping will be around the base of the sign. Four variances are requested: 1. Increasing the maximum square footage from 24 sq. ft. to 40 sq. ft; 2. Reducing the minimum required setback from 15 feet to 5 feet; 3. Reducing the maximum allowed height from 6 feet to 7 feet; and 4. Reducing the minimum required street frontage on an arterial road for the use of an EMC from 300 feet to 0 feet. Debra Stombres, PCPLD Executive Director, was present, and stated that the Library could really use this sign to make sure the area residents know about current and upcoming library programming and events. Trustee Harper confirmed there will be fixed panel identifying the Library and the EMC panel will have the changing message. Ms. Stombres asked the Board to consider waiving the first reading for the Ordinance.

Trustee Thon moved to waive the first reading. Trustee Haque seconded the motion. A voice vote approved waiving the reading. Trustee Thon moved to approve the Ordinance as presented. Trustee Harper seconded the motion. ROLL CALL:

A-23-088 Resolution – DAP Grant Request – 305 S. Bartlett Road

Request the Board approve a Resolution entitled "A RESOLUTION AUTHORIZING THE EXECUTION OF A DEVELOPMENT ASSISTANCE PROGRAM AGREEMENT WITH CYPRESS SQUARE BUILDING CONDOMINIUM ASSOCIATION IN THE VILLAGE OF STREAMWOOD." This Resolution approves a Development Assistance Program (DAP) grant for a roof replacement at the multi-unit commercial building located at 305 S. Bartlett Road.
