The purpose of this Public Hearing is for the Village Board to receive public testimony in reference to the proposed 2023 property and Special Service Area tax levies.

The tax levies as proposed by Village Staff have been and will continue to be available for inspection in the Village Clerk’s office.

This Hearing may be adjourned to another date without further notice other than a motion to be entered upon the minutes of this meeting fixing the time and place of its adjournment.

All interested parties are invited to sign in for the purpose of providing testimony.

Notice of this Public Hearing for the 2023 property tax levies was published on November 8, 2023 in the *Streamwood Examiner*.

No written testimony has been received. No one has signed in to provide verbal testimony.

Finance Director Josh Peacock noted the 2023 tax levy is equal to the 2022 tax extension. Contributions to the police and fire pension funds have increased by \$2 Million and are being offset by decreasing the General Tax levy amount to keep the levy “flat,”

**VILLAGE OF STREAMWOOD, ILLINOIS  
NOTICE OF PROPOSED PROPERTY TAX LEVY**

- I. A public hearing to approve a proposed property tax levy for the Village of Streamwood for 2023 will be held on Thursday, November 16, 2023 at 6:30 p.m. at the Village Hall, 301 East Irving Park Road, Streamwood, Illinois.

Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Kittie Kopitke, Village Clerk, 301 East Irving Park Road, Streamwood, Illinois, (630) 736-3800.

- II. The corporate and special purpose property taxes extended or abated for 2022 were \$12,211,009.

The proposed corporate and special purpose property taxes to be levied for 2023 are \$12,253,306. This represents a 0.3% increase over the previous year.

- III. The property taxes extended for debt service in 2022 were \$1,366,347.

The estimated property taxes to be levied for debt service in 2023 are \$1,324,050. This represents a 3.1% decrease from the previous year.

- IV. The total property taxes extended or abated for 2022 were \$13,577,356.

The estimated total property taxes to be levied for 2023 are \$13,577,356. This is the same amount as the previous year.
