A-23-102 Resolution – 5 Year Annual Audit Contract – Lauterbach & Amen

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING THE PROPOSAL AND AUTHORIZING THE VILLAGE PRESIDENT TO EXECUTE ON BEHALF OF THE VILLAGE, AND AUTHORIZING THE VILLAGE CLERK TO ATTEST TO A CERTAIN AGREEMENT WITH LAUTERBACH AND AMEN, LLP, CERTIFIED PUBLIC ACCOUNTANTS." This Resolution authorizes a contract with Lauterbach & Amen, LLP, to conduct the annual audit for the Village of Streamwood in 2023 with an option through 2027 for a total of five years.

Trustee Hashmi presented the Resolution and moved for approval. Trustee Haque seconded the motion. Finance Director Josh Peacock stated a Request for Proposals for audit services was prepared; one proposal was received from Lauterbach & Amen. The Village has used Lauterbach & Amen for the past 10 years and have been very pleased with their services. It is past practice to get new proposals every 10 years; however, there are limited numbers of audit firms who specialize in municipal audit work. The fees are reduced from 2022 by 2% for 2023, and increase by 4% each year for the five years covered by this contract. Jen Martinson, Lauterbach & Amen, was present for questions. Attorney

Adam Durkin confirmed for Trustee Cecille that the Village has annual renewal terms if there were any unexpected or undesired corporate changes within Lauterbach & Amen. ROLL CALL:

A-23-103 Resolution – DAP – 7-Eleven/Mobil – 2 E. Irving Park Road

Request the Board approve a Resolution entitled "A RESOLUTION AUTHORIZING THE EXECUTION OF A DEVELOPMENT ASSISTANCE PROGRAM AGREEMENT WITH 7-ELEVEN, INC. IN THE VILLAGE OF STREAMWOOD." This Resolution approves a \$22,012 Development Assistance Program grant request for landscaping improvements at the 7-Eleven/Mobil gas station located at 2. E. Irving Park Road.

Community Development Director Jeff Harris reviewed that 7-Eleven had a Planned Unit Development agreement approved by the Village Board early this year for major improvements to their site. With the major work still upcoming, the landscaping will likely be installed sometime next calendar year; they have 12 months to complete. A representative from 7-Eleven was present for questions. A-23-105 Resolution – Route 59 Bridge and Path – Engineering Services

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN ENGINEERING SERVICES AGREEMENT FOR SUPPLEMENTAL PHASE 2 ENGINEERING SERVICES WITH TRANSYSTEMS FOR THE ROUTE 59 BRIDGE AND TRAIL IMPROVEMENT PROJECT." This Resolution approves an amendment to an existing Phase 2 engineering agreement for the Route 59 bridge and path improvement project at an estimated cost of \$58,112.

Public Works Director Matt Mann reviewed that the first bid for the bridge came in much higher than expected; this bid was rejected.
