A-24- 015 Resolution – Sewer Cleaner Purchase – Standard Equipment Co.

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE PURCHASE OF A SEWER CLEANER FOR THE VILLAGE OF STREAMWOOD." This Resolution approves the purchase of a 2024 Vactor 2100 from Standard Equipment Co. The purchase price of \$499,041.15 includes trade-in value, delivery, training, and an extended 3-year parts and labor warranty. Funds for the purchase of this vehicle are included in the 2024 Equipment Replacement Fund (ERF).

Trustee Haque presented the Resolution and moved for approval. Trustee Cecille seconded the motion. Public Works Director Matt Mann and Lead Foreman Brian Spaid presented information on the proposed 2024 Vactor which will replace a 2008 Vactor (being traded-in with this purchase). The Vactor is a combination machine that macuums and has a high-pressure hose to flush the sewer. It also has a hydraulic excavator often used when working around utility lines. Comparative prices were obtained and the Sourcewell price through Standard Equipment Company was the lowest. Mr. Spaid presented a short video showing the equipment and its functions. ROLL CALL:
