A-24-040 Resolution – Adjustment in Greens Fees – Streamwood Oaks Golf Club

A-24-043 Resolution – Letter of Intent to Purchase Salt from State of Illinois

Request the Board approve a Resolution entitled "A RESOLUTION OF THE VILLAGE OF STREAMWOOD AUTHORIZING THE PURCHASE OF ROCK SALT FOR USE WITHIN THE VILLAGE OF STREAMWOOD FOR THE 2024/2025 WINTER SEASON." This Resolution authorizes the execution of a letter of intent to purchase salt through the State of Illinois for the upcoming winter season.

This Resolution approves an update to the Illinois Emergency Management Mutual Aid Intergovernmental Service Agreement.

This is like mutual aid agreements for police (ILEAS), Fire (MABAS), and Public Works (IPWMAN); this Agreement provides mutual aid when needed for large-scale emergency management needs providing access to other resources and funds from the immediate district (District 4), and potentially throughout the state. This Agreement has some language cleanup and clarifies liability to the municipalities. It also will be consistent with the other state mutual aid agreements. ROLL CALL:
