A-24-048 Ordinance – Amending Rules and Regulations for the Board of Fire and Police Commissioners

Request the Board approve an Ordinance entitled "AN ORDINANCE APPROVING THE REVISED AND AMENDED RULES AND REGULATIONS OF THE VILLAGE OF STREAMWOOD BOARD OF FIRE AND POLICE COMMISSIONERS STREAMWOOD, COOK COUNTY, ILLINOIS." This Ordinance modifies the Rules of the Board of Fire and Police Commissioners to permit non-US Citizens to apply for the positions of police officer or firefighter/paramedic.

Police Chief Shawn Taylor explained this Ordinance change the citizenship status requirement for police officers and firefighter/paramedics. Applicants won't be required to be U.S. citizens, but they must be authorized to work in the U.S. Candidates must still

pass a written and oral examination, provide proof of physical fitness, pass all post-offer pre-employment examinations, the academy (if applicable), and complete a probationary period.
