A-24-048 Ordinance – Amending Rules and Regulations for the Board of Fire and Police Commissioners

A-24-053 Resolution – Professional Services Contract – PACE Scheduling System

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE POLICE CHIEF TO EXECUTE, ON BEHALF OF THE VILLAGE, A MULTI-YEAR SERVICE AGREEMENT WITH PACE SYSTEMS, INC. FOR THE PACE SCHEDULER COMPUTER SCHEDULING PROGRAM FOR THE VILLAGE OF STREAMWOOD POLICE DEPARTMENT." This Resolution authorizes a contract to purchase a scheduling and timekeeping system for the Police Department.

Trustee Hashmi presented the Resolution and moved for approval. Trustee Haque seconded the motion. Police Chief Shawn Taylor reviewed the PACE time-keeping system (which is already being used in the Fire Department) and stated this system will be a vast improvement over the current system. It is fully compatible with MUNIS as well. The agreement is ongoing and may be terminated by either party at any time. The cost is \$4,800 for one year, which includes technical support. Trustee Cecille asked about overtime scheduling. Chief Taylor provided a brief outline of the scheduling, stating it varies by need, seniority, and rotation. ROLL CALL:

A-24-054 Resolution – Waiving Competitive Bidding and Purchasing Two (2) Vehicles

Request the Board approve a Resolution entitled "A RESOLUTION OF THE VILLAGE OF STREAMWOOD WAIVING COMPETITIVE BIDDING, AND APPROVING AND AUTHORIZING THE VILLAGE TO PURCHASE TWO (2) VEHICLES FOR THE COMMUNITY DEVELOPMENT DEPARTMENT." This Resolution waives competitive bidding and authorizes the purchase of two (2) vehicles for the Community Development Department at a total cost of \$67,605 from Morrow Brothers Ford, Inc. Funds for this purchase are included in the 2024 Equipment Replacement Fund.

Trustee Bermudez presented the Resolution and moved for approval. Trustee Baumer seconded the motion. Community Development Director Jeff Harris stating the Board authorized purchase of two vehicles in July 2023; these vehicles were recently cancelled and will not be manufactured. None of the purchasing cooperatives are able to guarantee vehicle delivery through 2025. Morrow Brothers Ford specializes in government fleet vehicles; when contacted two weeks' ago, they had four Ford Escape vehicles available. They have since sold three of the vehicles. They are holding the one 2023 Escape and have a 2023 Maverick pickup available which is a suitable vehicle for us. ROLL CALL:

A-24-055 Resolution – Construction Bid – Madison Drive Path

Request the Board approve a Resolution entitled "A RESOLUTION DECLARING THE LOW BID, APPROVING AND AUTHORIZING THE EXECUTION OF A CERTAIN CONTRACT WITH A. LAMP CONCRETE CONTRACTORS, INC. FOR CONSTRUCTION OF THE MADISON DRIVE MULTI-USE PATH." This Resolution accepts the lowest most responsible bid for the construction of a new multi-use pedestrian and bicycle path from A Lamp Concrete, Inc. for \$634,000. Funds for this work are included in the 2024 Street Fund, and a grant from the US Dept. of Housing and Urban Development.

Trustee Thon presented the Resolution and moved for approval. Trustee Cecille seconded the motion. Public Work Director Matt Mann noted receipt of a federal grant of \$330,400 to support the construction of this multi-use path. The path will run along Madison Drive from Irving Park Road northward, with connections to Hoosier Grove Park, the Route 59 bridge boardwalk, and Creekside Park. Five bids were received with A. Lamp Concrete being the low bid. They are IDOT pre-qualified and have worked in Streamwood on

multiple projects in the past. This work is planned for after Summer Celebration to avoid conflicts for the event. Trustee Cecille asked if the path is concrete or asphalt. Mr. Mann stated it is mostly asphalt with some concrete where junctions are also concrete. ROLL CALL:
