VILLAGE MANAGER'S REPORT:

Village Manager Sharon Caddigan noted the start of DARE graduations this week. She also stated DARE officer Tom Sparks is retiring after 23 years on the police force; Officer Juan Campos has stepped up to become our newest DARE officer.

Ms. Caddigan reported that the Route 59 bridge project is underway with a very large crane being on-site. Pilings are being driven into the ground and ground sampling/testing is underway.

<u>COMMUNITY DEVELOPMENT – Trustee Bermudez/Trustee Baumer</u>

A-24-057 <u>Resolution – Residential Renovation Program – North West Housing Partnership</u>

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF AN AGREEMENT BETWEEN THE VILLAGE OF STREAMWOOD AND THE NORTH WEST HOUSING PARTNERSHIP FOR PARTICIPATION AND OPERATION OF THE SINGLE FAMILY HOME REPAIR AND HANDYMAN PROGRAM." This Resolution accepts an agreement with North West Housing Partnership to pilot a residential rehabilitation program for Village residents. Funds for the program were included in the 2024 Capital Replacement Fund.

Trustee Bermudez presented the Resolution and moved for approval. Trustee Cecille seconded the motion. Community Development Director Jeff Harris stated the Board asked to create a residential home repair grant program similar to the business development assistance program established in 2022. North West Housing Partnership (NWHP) based in Schaumburg, administers similar residential programs for several other area communities. After reviewing options, NWHP recommended the Single Family Repair (SFR) program and the Handyman Repair (HR) programs for Streamwood. The SFR program is intended to cover significant home repairs such as roof, siding, HVAC, electrical, plumbing or drywall repairs. The HR program is intended to cover basic improvements such as installation of lighting or plumbing fixtures, installation of grab bars, repairing window screens, painting, and cleaning gutters. The SFR program will have a maximum grant of \$25,000 as a 0% interest, 5-year deferred loan; the property must be owner occupied and if sold or transferred, the loan is to be repaid (20% owed for each year remaining on 5-year term). There are

specific income eligibility limits. The HR program will have a maximum grant of \$1,000 and property must be owner occupied. No income eligibility is required for the HR program.

The Village is providing \$100,00 in funding for the program to NWHP who will administer both programs. At the January Board workshop, it was determined that 90% of the funds would be allocated to the SFR program and 10% to the HR program; NWHP anticipated approximately 10-15% of total funds to cover administrative costs. Paula Bush, NWHP, was present and provided an overview of their work with other communities.

Trustee Cecille asked if condos are eligible for funding. Mr. Harris stated they could be eligible provided they meet the necessary criteria. Trustee Cecille also asked if a homeowner could apply for grants in multiple years. Mr. Harris noted it wouldn't be advisable to "stack" multiple loans and that it would likely be limited to one grant per property for a 5-year period. This entire program will be evaluated and can be modified if needed. ROLL CALL:
