### **VILLAGE MANAGER'S REPORT**:

Village Manager Sharon Caddigan reviewed the 4<sup>th</sup> of July fireworks display and complimented the excellent traffic direction from Streamwood Police and Hanover Township Emergency Management.

The Route 59 bridge work continues with foundation pier installation being planned for next week and the steel will be arriving soon.

An active threat drill was held at Oakhill School on July 9 and 11 with various area agencies participating.

The Junior Police Academy is finishing this week with 29 students enrolled.

The Village successfully launched its Facebook page and the Public Safety Facebook page on June  $28^{th}$  – we have over 1,000 followers for each of the pages.

Streamwood saw some tree damage and limited power outages during the stores that passed through on July 15 and 16. Police, Fire and Public Works all worked to ensure the safety of the residents.

A-24-070 <u>Resolution – Professional Engineering Services - Kollar Pond Phase 2 – Confluence, Inc.</u>

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE EXECUTION OF A PROFESSIONAL SERVICES AGREEMENT WITH CONFLUENCE, INC. FOR SECTION 1, PHASE 2 ENGINEERING AND ARCHITECTURAL SERVICES FOR KOLLAR POND." This Resolution accepts a contract for Phase 2 professional architectural and engineering services for Section 1 of the Kollar Pond project.

Trustee Thon presented the Resolution and moved for approval. Trustee Bermudez seconded the motion. Public Works Director Matt Mann noted Confluence is the design engineer for the entire Kollar Pond project (String of Pearls). This contract is for Phase 2, Section 1 which includes pond reshaping and renovation, and the Northwest Gateway which includes the main entry area, garden gateway, performance pavilion and amphitheater. This initial section also includes the pond fountain, path around the pond and the interactive wood sculptures in the South Pearls. Confluence will prepare the architectural and engineering plans to be ready for construction bidding in late 2025; actual construction will depend on funding. The estimated cost is \$537,720. Preparation of these documents will allow the Village to apply for grant funding. ROLL CALL:

### A-24-071 Resolution – Pumper Fire Truck Purchase – Fire Department

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE PRESIDENT TO EXECUTE A SALES CONTRACT FOR THE PURCHASE OF A PUMPER FIRE TRUCK." This Resolution authorizes the purchase of one (1) 2027 fire engine (pumper) from E-One Cyclone for a cost not to exceed \$1,243,483. Funds for this vehicle are included in the Equipment Replacement Fund.

Trustee Thon presented the Resolution and moved for approval. Trustee Hashmi seconded the motion. Fire Chief Mike Meyer stated Engine 33 is scheduled for replacement in 2026. The lead time for actual delivery of a new truck is now 36-39 months due to labor and supply chain shortages. Placing the order now will have the truck ready for delivery in 2027; payment is not due until delivery. Engines are on a 10-

year replacement cycle; Engine 33 will be 12 years in 2027 and will be kept as a reserve engine as long as it still has useful life. This contract is through the Sourcewell Cooperative group purchase program. Trustee Baumer confirmed the price is fixed. ROLL CALL:

A-24-074 Resolution – Ambulance Billing Services Agreement – Paramedic Billing Services, Inc.

Request the Board approve a Resolution entitled "A RESOLUTION APPROVING AND AUTHORIZING THE VILLAGE PRESIDENT TO EXECUTE AN AMBULANCE SERVICES AGREEMENT WITH PARAMEDIC BILLING SERVICES, INC." This Resolution accepts a new contract and vendor for ambulance billing services.

Trustee Baumer presented the Resolution and moved for approval. Trustee Haque seconded the motion. Fire Chief Mike Meyer noted the Village has used a third-party ambulance billing company for more than 20 years. The current company was recently sold and absorbed into a large out-of-state company. Their service and customer care is not meeting our needs, and the contract ends on September 30, 2024. After assessment of several other vendors, and checking with other area departments, it is recommended to switch ambulance billing services to Paramedic Billing Services, in Elmhurst, IL. They are offering a three-year contract at 4.9% of net collections; the current provider is at 5%. The annual cost is estimated at \$40,000 based on projected ambulance billing net proceeds and is dependent on collections received. ROLL CALL:

### A-24-075 Resolution – Internet Router Equipment for Fire Vehicles

Request the Board approve a Resolution entitled "A RESOLUTION WAIVING COMPETITIVE BIDDING, ACCEPTING, APPROVING AND AUTHORIZING THE PURCHASE OF CRADLEPOINT MODEMS FOR THE FIRE DEPARTMENT." This Resolution waives formal competitive bidding to purchase eleven (11) wireless internet routers for fire department vehicles at a cost not to exceed \$30,348.89.

Trustee Hashmi presented the Resolution and moved for approval. Trustee Haque seconded the motion. IT Director Joe Ritter noted the current routers in Fire vehicles are nearing the end of their life and need to be replaced. These routers will match the ones the Police Department is using in their vehicles; the internet carrier is also offering a \$1,000/router savings on their service fee for this upgrade providing a \$26,000 service fee credit from Verizon. Three responsible vendors provided quotes for the routers; Discount Cell, LLC was the low quote and is a direct provider. Village staff will do the installation. ROLL CALL:

#### A-24-076 Resolution – Agreement Amendment – Axon Enterprises Inc.

Request the Board approve a Resolution entitled "A RESOLUTION WAIVING COMPETITIVE BIDDING, ACCEPTING, APPROVING AND AUTHORIZING THE PURCHASE OF CRADLEPOINT MODEMS FOR THE POLICE DEPARTMENT." This Resolution waives formal competitive bidding and amends an existing agreement to provide higher speed capacity wireless internet routers for police vehicles at an increased cost of \$28,662.56.

Trustee Hashmi presented the Resolution and moved for approval. Trustee Bermudez seconded the motion. Police Chief Shawn Taylor stated the fleet camera systems in each patrol vehicle are being replaced by Axon Enterprises, Inc as part of the planned equipment implementations. The previous contract included 4G modems; we are recommending upgrading to the 5G Cradlepoint modems for a net cost increase of \$28,662.56 for the five-year contract with Axon. The Department of Treasury Funds include sufficient funds for this purchase. ROLL CALL:
