A-24-080 Ordinance – Zoning Text Amendment

Request the Board approve an Ordinance entitled "AN ORDINANCE AMENDING CHAPTER 2 ENTITLED "DEFINITIONS," CHAPTER 6 ENTITLED "COMMERCIAL DISTRICTS," AND CHAPTER 13 ENTITLED "ADMINISTRATION AND ENFORCEMENT" OF TITLE 11 ENTITLED "ZONING" OF THE VILLAGE CODE OF ORDINANCES OF THE VILLAGE OF STREAMWOOD." This Ordinance amends the Zoning Code to allow, as a special use, body art establishments in certain commercial districts.

PUBLIC SAFETY - Trustee Hashmi/Trustee Cecille

A-24-083 Ordinance – Municipal Code Amendments

Request the Board approve an Ordinance entitled "AN ORDINANCE AMENDING THE VILLAGE CODE OF ORDINANCES OF THE VILLAGE OF STREAMWOOD." This Ordinance amends various sections in Titles 1, 3, 4, and 5 of the Village of Streamwood Municipal Code, including changes that add certain parking restrictions, strengthen regulations for police vehicle enforcement, create business licensing regulations for body art establishments, eliminate an existing position, and update language in compliance with said amendments, policies, and standards.

Trustee Cecille presented the Ordinance for first reading and posting.

Attorney Adam Durkin reviewed the proposed changes, including elimination of the appointed office of Collector as of April 30, 2025 and removes all references to Village Collector through the Code; regulations regarding body art establishments, including operating hours, inspections, background checks; expands the Police authority to enforce parking restrictions on Village streets for non-motorized vehicles, trailers or campers not mounted to a vehicle, and also allows impoundment of vehicles used to flee or elude an officer; updates the bond requirements and duties of the Finance Director regarding the bond amount and issuing payments pursuant to the Village's purchasing policy.

Trustee Cecille confirmed that parking restrictions for trailers, boats, etc. not mounted to a vehicle would be enforced at all times rather than just for overnight parking, etc.
