A-21-079 Resolution – Storage Area Network (SAN) Replacement

Request the Board approve a Resolution entitled "A RESOLUTION ACCEPTING A PROPOSAL, APPROVING AND AUTHORIZING THE VILLAGE PRESIDENT TO EXECUTE ON BEHALF OF THE VILLAGE AND AUTHORIZING THE VILLAGE CLERK TO ATTEST TO A CERTAIN PURCHASE ORDER WITH MINDSIGHT, LLC TO PROVIDE STORAGE AREA NETWORK REPLACEMENT." This Resolution authorizes the purchase of back-end computer storage equipment at a cost not to exceed \$79,046.58. Funds for this purchase are included in the 2021 Facilities and Equipment Replacement Fund (FERF).

Trustee Harper presented the Resolution and moved for approval. Trustee Schmidt seconded the motion. IT Director Joe Ritter stated this is a planned replacement for the existing back-end Storage Area Network (SAN) that has been in use since 2015 and has a life expectancy of 5 years. Three responsible vendors were asked for quotes for the work and product; Mindsight is the middle of the quotes at \$79,046.58 (estimate was \$100,000) and meets all of our expectations. They are also the current

provider and there have been no issues with their product, implementation, support, service and stability. Trustee Harper asked about the warranty. Mr. Ritter stated it is a three year warranty; starting with year four, the cost is approximately \$8,500/year. Trustee Schmidt asked the location of the equipment. Mr. Ritter stated it is in the lower level of Village Hall and also at the Police Department. Trustee Schmidt also confirmed that the quoted cost includes full configuration and implementation.
