A-21-081 Resolution – Approval of Bid and Contract / Sewer Pipe Lining

Request the Board approve a Resolution entitled "A RESOLUTION DECLARING THE LOWEST RESPONSIBLE BIDDER, APPROVING AND AUTHORIZING THE VILLAGE PRESIDENT TO EXECUTE ON BEHALF OF THE VILLAGE AND AUTHORIZING THE VILLAGE CLERK TO ATTEST TO A CERTAIN CONTRACT WITH HOERR CONSTRUCTION, INC. FOR SANITARY AND STORM SEWER REHABILITATION." This Resolution approves the low bid and authorizes the Village to enter into a unit price contract with Hoerr Construction, Inc., 1416 County Road 200N, Goodfield, IL for sanitary and storm sewer rehabilitation at an estimated cost of \$549,575.00.

Trustee Harper presented the Resolution and moved for approval. Trustee Baumer seconded the motion. Public Works Director Matt Mann stated this storm and sanitary sewer lining will take place in 14 neighborhoods for approximately 12,540 feet of liner. The pipe sizes vary from 8 inch to 18 inch pipes and extends the life of the pipe as well as helping to meet the MWRD requirements for inflow and infiltration. Three bids were received with Hoerr being the low qualified bid. They have worked successfully in the Village for several prior years. Trustee Cecille asked about work on Park Boulevard; Mr. Mann reassured Trustee Cecille there would be no digging of the newly paved street. ROLL CALL:

LEGISLATIVE - Trustee Haque/Trustee Schmidt

A-21-084 Ordinance – Personnel Policy Manual Changes

Request the Board approve an Ordinance entitled "AN ORDINANCE AMENDING TITLE 1, CHAPTER 11 OF THE VILLAGE CODE OF STREAMWOOD AMENDING THE PERSONNEL POLICY MANUAL." This Ordinance makes changes to the Village's Personnel Policy to ensure consistency with recent state statute changes regarding whistleblower protection and makes other changes consistent with our policies.

Trustee Haque presented the Ordinance for first reading and posting.

Attorney Tom Bastian stated there are two amendments in the Personnel Policy needed due to legislative changes in the state law. One is for the Retaliation Against Whistleblower Protection Act that mandates an auditing official for receiving and investigating complaints. The Village Manager will be the auditing official; in case of a conflict, the Village Attorney would be appointed. The second amendment moves a provision from Section II (applicable only to non-union personnel) to Section I (applicable to all employees) regarding VESSA (Victims' Economic Security and Safety Act). There are no changes to the language, just the placement in the section of the manual.
