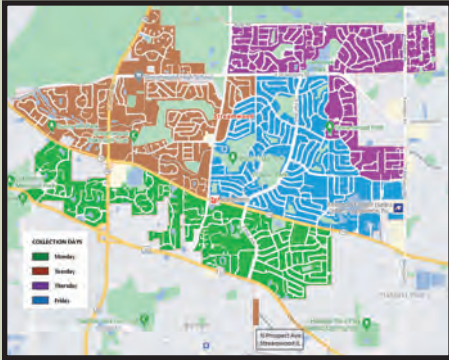

## New Waste Hauler

The Village Board approved a contract for a new refuse and recycling contractor. **Groot Industries** will serve as the Village's new waste hauler starting July 1, 2021.

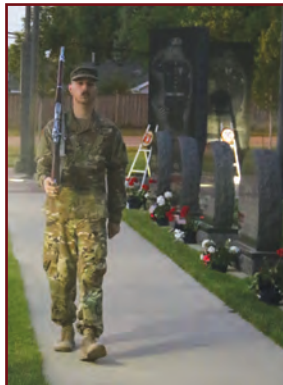
**Residents should see a 10% reduction in the cost of service.** Very little will change with the new provider. Toters will continue to be used. Yardwaste pick-up will continue in Kraft bags or in designated cans with the \$1.00 Village yardwaste sticker. Most residents will retain their same pickup day (see map). A new provision will allow residents to dispose of e-waste on a fee basis like the disposal of white goods (i.e., appliances). Groot will be sending information directly to residents soon. Questions? ## Memorial Day 2021

The Streamwood Veterans Commission has announced that it will hold its annual Memorial Day Observances May 29-30. The Observance will begin with an in-person **POW/MIA Candlelight Vigil** on **Saturday, May 29 at 8:00 pm**. The Vigil Guard will patrol the Memorial throughout the evening. On **Sunday, May 30 at 11:00 am**, the Vigil Guard will be retired to formally begin the Memorial Day Observance.

Due to continued COVID-19 concerns and state restrictions, the ceremony will be slightly different. Masks will be required for all attendees and participants. Social distancing will be maintained.

While scaled back in response to the pandemic, the Village Board and Veterans Memorial Commission are proud to host a limited event to honor those who have given their greatest gift in service to our country.

## Junior Police Academy

The Streamwood Police Department will be offering a Junior Police Academy July 19-23. If you're a current or incoming middle-school student who wants more information about our police department, we encourage you to apply!

The Academy is geared to students entering 6th, 7th, or 8th grade. Students will participate in activities such as simulated crime scene investigation, evidence collection techniques, traffic stops and interdiction, and learn about internet safety, bicycle safety, patrol operations and investigations, as well as specialized areas of the department including DARE, special operations, and police social work.

## Trustee William J. Carlson Retires

On April 29, the Village recognized the outstanding public service career of William J. Carlson who served as a Village Trustee for 32 years. He did not seek another term in the recent election, choosing to retire to spend more time with family.

Bill and his wife, Caroline, moved to Streamwood in 1961 to raise their two children. At that time, the population was just over 4,800. Bill was first elected Village Trustee in 1989. As a Board member for over three decades, Trustee Carlson helped make policy decisions necessary to maintain and enhance the health, safety, and welfare of our community. He was an advocate for the Village's infrastructure plans including the annual road program and Lake Michigan water. He believed strongly in supporting the programs and services our residents expect and deserve. He supported our pay-as-you-go philosophy as a foundation to keeping Streamwood running efficiently for its residents and businesses.

Members of the current and past Village Board and staff, along with neighboring dignitaries, were on hand to recognize his contributions. On behalf of the residents of Streamwood, the Village Board and staff would like to thank Bill for his dedicated service.

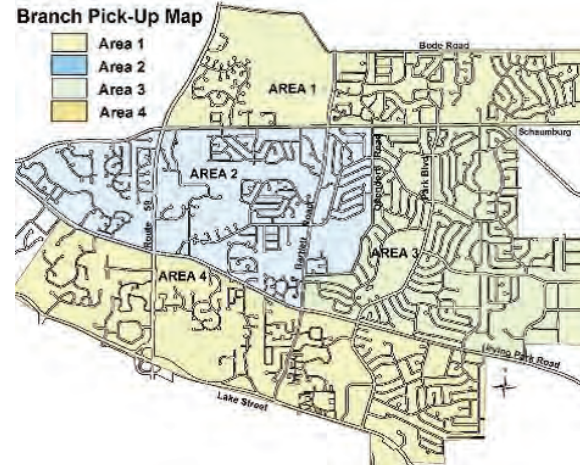

**Branch Pickup**

Through October, Public Works will collect branches, free of charge, from your curbside during designated collection days. Simply place branches at the curb by 6:00 am on the day your area is scheduled for pickup. It is important to have your branches out by the scheduled morning listed below in order to avoid being missed by the branch pickup crews. Crews collect branches as soon as possible but cannot be expected to return if branches are not out in time.



Branches must be placed with the cut ends facing the street. Branches cannot be longer than ten feet (10') in length, and have a diameter of no larger than six (6) inches.

The Village is divided into four areas for pickup service (see map). Each area receives branch pickup service one time per month.
