**VILLAGE OF STREAMWOOD, ILLINOIS  
NOTICE OF PROPOSED  
PROPERTY TAX LEVY**

- I. A public hearing to approve a proposed property tax levy for the Village of Streamwood for 2022 will be held on Thursday, November 17, 2022 at 6:30 p.m. at the Village Hall, 301 East Irving Park Road, Streamwood, Illinois.

Any person desiring to appear at the public hearing and present testimony to the taxing district may contact Kittie Kopitke, Village Clerk, 301 East Irving Park Road, Streamwood, Illinois, (630) 736-3800.

- II. The corporate and special purpose property taxes extended or abated for 2021 were \$11,814,522.

The proposed corporate and special purpose property taxes to be levied for 2022 are \$11,855,349. This represents a 0.3% increase over the previous year.

- III. The property taxes extended for debt service in 2021 were \$1,367,377.

The estimated property taxes to be levied for debt service in 2022 are \$1,326,550. This represents a 3.0% decrease from the previous year.

- IV. The total property taxes extended or abated for 2021 were \$13,181,899.

The estimated total property taxes to be levied for 2022 are \$13,181,899. This is the same amount as the previous year.
