If barricades are damaged, you will be billed for the repairs/replacement.

To arrange for the Police Department to visit your event, please call the Shift Commander or Sergeant at (630) 736-3700.

2. That certain streets at certain times must be identified by the Village as necessary thoroughfares which may not be closed at the times requested.
3. That the earliest time and date of filing Application shall be the deciding factor should there be areas of conflict resulting from two or more applications.
4. That all residents of the portion of the street to be closed concur to the use of the street for a street/block party.
5. That the events planned and conducted are in accordance with the law and will be conducted in such manner no as not to be offensive to other residents in the area.
6. That only Village-provided barricades will be used.
7. That the use of the street be planned to allow passage of emergency vehicles to points within the closed area.
8. That residents are responsible for cleaning up and removal of all debris and garbage from public property.
